I, Ashwani Kumar Mishra (Ex.I.A.F / Dy Manager PGCIL) S/o Late Sh Mukta Prasad Mishra, resident of 2/298, Nawabganj , Kanpur, wish to seek information under the RTI Act, 2005 from POWERGRID. I, hereby declare that I am a Citizen of India and information sought in this application will be used in the best of the undersigned interest. I, further assure you that I shall not allow to use /pass/share/display/or circulate the information received in any case and under any circumstances, with any person or in any manner which would be detrimental to the unity /sovereignty or against the interest of India.

I, had been superannuated from POWERGRID, Kanpur w.e.f 31<sup>st</sup> July'2014,having zero payment (copy enclosed) for the last month of my service rendered i.e July'2014 without having any prior specific notification, resulted deep mental agony on account of social & financial humiliation on superannuation day to an employee rendered 27 years of outstanding services to POWERGRID & 17 years to I.A.F., left no stones unturned during service carrier and accomplished all the tasks assigned with utmost satisfaction of organizational goals,


Having no satisfactory clarification from the competent office till date, I am forced to seek information as follows, under the RTI Act, 2005.

- I am coerced by this existence to beseech for justice to have information on legal prerogative of corporation to make my salary 0 (Zero) for the month of July'2014, that too the last month of my service period in POWERGRID before superannuation without giving any prior specific notification.
- If reason for above is recovery against any outstanding dues ,it could have been intimated in advance to manage the recovery in installments to save an employee from mental & financial thirst, departing on starvation on account of superannuation, may please be clarified and informed.
- It is self-indicative that an employee proceeding on superannuation used to clear all the dues under direction of HR for ensuring no dues outstanding on the last day, already complied if not may please be clarified and informed.
- It is almost one & half year is passing after superannuation corporation has not provided any detail statement supposed to be provided immediately after superannuation as mandatory financial information basically and necessarily required by superannuated employee in order to evaluate, various due payments released till date or to ensure any payment pending as on date, information also desirable for income tax assessment/review.
- Ref superannuation benefit Handbook: Annex-VIII(Post-Retirement Medical Benefit) under heading\_Benefit for indoor treatment is not practically and logically defined causing a critical sufferings and hardship specially when a superannuated employee, supposed to be treated as senior citizen, falls ill during stay away from his home station and needs reference letter ,no procedure of reporting sickness(obtaining Ref-Letter) during stay away from his home station is defined needs attention in compliance, extend proper information .
- Ref : Ceiling limit: Appropriate reason/logic for one-time payment of ceiling contribution of Rs 7200/- by Executive at the time of superannuation may please be specifically clarified.
- Why action should not be taken on account of financial and mental stress suffered by an superannuated executive without any reason.
