1. How many F&A candidates participated in the ACGS 2015, please give cadre wise details.

Reply. In the ACGS 2015, a total of 12 F&A candidates participated. 05 of the candidates were from the Supervisory cadre and the rest 07 were from the Workmen cadre.

2. Also provide the stage wise marks of all candidates: like experience marks, AAR Marks, qualification marks, Group Discussion Marks and Interview Marks scored in ACGS 2015.

Reply. AAR gradings cannot be disclosed as the same is exempted from disclosure to third party as per Section 8(1)(j) of the RTI Act. This has been upheld in the CIC decision dated 01.02.2016 in the Ajay Sharma vs Power Grid Corporation of India Ltd. case.

Other details like like the Experience Marks, Group Discussion and Interview Marks are a part of the Committee Proceedings which contain personal information of candidates and are thus, confidential in nature. This would constitute third party information which is exempt from disclosure under Section 8(1)(j) of the RTI Act, 2005. This has also been upheld in the Hon'ble High Court of Delhi judgment dated 08th July, 2014 in the THDC India Ltd. Versus R.K. Raturi case.
