## ANNEX-I

### Query:

1. An eligibility criteria was fixed for empanelment of transformer manufactures for supply of DTRs in Deen Dayal Upadhya Scheme of electrification. The basis on which the eligibility criteria was framed may kindly be provided with copies of all supporting documents circulated in this regard.

### Reply:

Under its initiative to facilitate states in mobilization of quality equipment/materials at competitive prices under DDUGJY/IPDS schemes, Ministry of Power vide its notification no. 44/30/2015-RE dated 14.08.2015 has constituted two Committees namely Committee 'A' and Committee 'B' with their respective defined terms of reference. Under this, Technical Specification was finalized by Committee 'A' whereas Bidding documents including Qualification Requirement was finalized by Committee 'B' after deliberations in its various meetings.

2. It is understood that Prime Minister of India has mandated all govt./quasi govt. bodies to promote micro/mini/small and new enterprises etc. so as to bring them upto a certain level for their sustainability. What measures has been taken by your department in the process of empanelment of transformer manufacturers for Deen Dayal Upadhya Scheme to nurture the vision of our honourable prime minister. Pls provide detailed description of such measures in respect of the said empanelment process.

### Reply:

Please refer to reply at Query No.-1. As brought out therein, the subject process is for and on behalf of states. The aforesaid committees are thus only facilitating state utilities in mobilization of quality equipment/materials at competitive prices under DDUGJY/IPDS schemes. To effect the same, upto price discovery in a transparent manner for different items are undertaken by Committee B which is then further communicated to state utilities for taking any further action in this regard.
