THE RIGHT TO INFORMATION ACT

1. Can someone working with a company under Ministry of Power, Gol, encash his/ had earned leaves at credit after his/ her resignation is accept and he/ she has been released provided he/ she does not join another Central/ State Govt organization. If yes, then for how many day EL can be encashed.

Reply: The information sought by you is in the nature of query/clarification/justification and does not come under the ambit of RTI Act, 2005. As per the provisions of RTI Act, 2005, Public Authority can only provide information which already exists with the Public Authority or held under his control. The Public Authority is not supposed to create information, or to interpret information.

2. Can someone working with a company under Ministry of Power, Gol comeback to the same company once his/ her resignation is accepted and he/ she has been released from service. If yes, is there any time limit for his return joining. What is the procedure for the same.
