For compiling such voluminous information, a considerable amount of resources would have to be deployed by POWERGRID and it would disproportionately divert the resources of the public authority. Therefore, in line with section 7 (9) of the RTI Act, aforesaid information is not being provided. However, in the event information regarding any specific organization/ NGO is sought same can be provided.
