


SL.No	Information Sought about	Reply
1)	What are all the guidelines stipulated, if such HT lines are laid inside the Residential complex.	The guidelines given in "CEA (Measures relating to Safety & Electricity Supply) Regulations, 2010" (The same can be downloaded from the website of Central Electricity Authority (www.cea.nic.in)) and the electrical clearances specified in "Manual on Transmission Lines of Central Board of Irrigation & Power" (The same can be purchased online from Central Board of Irrigation & Power (www.cbip.org)) are followed by POWERGRID while constructing HT Lines.
2)	What are all the guide lines to be followed by the builder.	
3)	Is there any references made to National building code.	
4)	Can car parking, Two wheeler parking and open theatre under HT Lines allowed	
5)	If yes, What are all the conditions to be followed.	The builders of Residential Complexes are also required to adhere to the above statutory electrical clearances when constructing complexes near HT Lines.
