

Query:

1. Please clarify whether Demerged Unit approved by Power Grid Corporation of India 1.td for supply of materials meeting all technical requirements can participate in future tenders of Power Grid Corporation of India 1.td. with its new entity name i.e. Nu-line Industries Pvt 1.td. after Demerger from present company i.e. Sturdy Industries 1.td. (Power Grid approved Company). Since Demerged unit is a new entity and does not have last 5 years financials except its parent Company.

This Demerged unit can furnish all the financials of its parent company only since it is now new entity after demerger for considering eligibility to participate in forthcoming tenders of Aluminium Conductors.

Reply:

The Eligibility and Qualifying Criteria are stipulated in the respective Tender Documents.

You may also note that the query is not covered under the definition of 'information' as defined under RTI Act 2005 as toflows:

"information" means any material in any ferm, including records, documents, memos, e-mails, opinious, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;"
