

3. GATE 16 rank, upto which each category of candidates were called for interview.

Reply 3: During the recruitment for the above post through GATE 2016, only the normalized marks obtained by the applicants (out of 100) in the GATE examination were a part of the selection process and no GATE rankings were used. The same had also been notified in the detailed notification 01/2016 dated 11.01.2016 as follows:

“The Selection Process consists of marks obtained (out of 100) in the corresponding paper of GATE - 2016, Group Discussion & Personal Interview.”

In view of the above, data pertaining to rank of the selected candidates is not maintained by POWERGRID and hence cannot be provided under the RTI Act 2005.
