

Information Sought under RTI Act, 2005 by Shri Patitapabana Sahu, Plot No. 546, Sahid Nagar, Bhubaneshwar - 751007

- Please provide me the certified Xerox copy of the connectivity permission applied by GMR Kamalanga Energy Ltd. to lay the 400 kV Transmission line from GMR to Meramundali Grid including the land schedule of the Transmission line route
- 2. Please provide me the certified Xerox copy of the permission given by OPTCL to GMR Kamalanga Energy Ltd. to lay the 400 kV transmission line

Reply (1&2): The permission to lay the transmission lines (400 kV S/C line from GMR TPS to Meramundali Substation owned by OPTCL in the instant case) do not fall under the purview of CTU (i.e. POWERGRID).

3. Please provide me the certified Xerox copy of date of energization of 400 kV line from GMR to Meramundli Grid

Reply: The GMR TPS- Meramundali 400 kV S/C line has been commissioned in March, 2015, as per the information provided by GMR Kamalanga Energy Ltd. in the 6th Joint Coordination Committee Meeting of Eastern Region held on 26.05.2015 and the minutes of the meeting are available at POWERGRID website (ww.powergridindia.com>>CTU Open Access).
