

Reply to RTI Query by Sh. Vineet

1.	Information sought	The query is in respect of advt no. CC/02/2015, recruitment of M.Tech/Ph.D professionals, why is the process taking so long, it's been more than 1.5 years since the advertisement came out.
	Reply	There were posts in 9 disciplines advertised through advertisement no. CC/02/2015. Out of 9 disciplines, 8 were to be filled by PhD or MTech candidates (preference was to be given to PhD candidates). Accordingly, we have been scheduling the interviews in phased manner since January 2016 onwards. Interviews for several posts have already been conducted and the status have been updated on candidate login. Status of the remaining processes are being updated shortly.
2.	Information sought	How to check status of the recruitment process
	Reply	We give all the information on Candidates Login. We send sms and mail to shortlisted candidates to update them regarding interview.
3.	Information sought	When can I expect the interview process to start and what would be the gap (in months) between the selection and joining date.
	Reply	You have to check the candidate login section of respective post on career page, there we update the status of your candidature.
