This has reference to your RTI request dated 5th October, 2016, seeking information under RTI Act, 2005. The information sought is given below:

- (1) Document showing power flow to be catered (total transfer capability) with the \pm 800 kV Champa – Kurukshetra HVDC bi-pole link is available on POWERGRID website (www.powergridindia.com → CTU open access → TTC/ATC).
- (2) Upgradation of Champa & Kurukshetra Terminal was awarded in 22.07.14 and work started in August, 2014.
- (3) \pm 800 kV, 3000 MW Champa – Kurukshetra HVDC bi-pole link is a part of High Capacity Power Transmission Corridor–V (HCPTC–V) for transfer of power from various IPPs in Chhattisgarh under Long Term Access. The document showing the names of the IPPs and their share of power along with beneficiaries for which LTA was granted with HCPTC–V is available on POWERGRID website www.powergridindia.com → CTU open access → Application Details (Connectivity/LTA/MTOA application status) → Long Term Open Access Application (List of Applications Granted) .
