Dear Sir,

This has reference to your RTI request dated 15<sup>th</sup> October, 2016, seeking information under RTI Act, 2005.

It is to inform that under its initiative to facilitate States in mobilization of quality equipment/materials at competitive prices under DDUGJY/IPDS schemes, Ministry of Power vide its notification no. 44/30/2015-RE dated 14.08.2015 constituted two Committees, namely Committee 'A' and Committee 'B' with their respective defined terms of reference. These committees were with members from different organizations/states, of which POWERGRID was also a member. As authorized by the committee, POWERGRID carried out the empanelment/bidding under the subject process in line with the provisions of the RfE and RfP documents, which are in public domain itself.

Further, the information sought is voluminous in nature and gathering of this information would disproportionately divert resources of the Public Authority.

Therefore, in the event, you desire to inspect any specific documents/records, you can do so by visiting our Corporate Office on any working day with prior intimation. You are also advised to intimate us about your proposed date & time of visit at least two weeks in advance and the specific records you wish to inspect, so that documents are kept ready for inspection. It may please be noted, in the event you desire to avail photocopy of any concerned document, the same shall be made available on payment of applicable charges.
