

Question No. i) Yes, Ministry of Power has issued guidelines for RoW compensation on Oct.15, 2015. The said guidelines is available on the foilowing link:

- Question No. ii) As per the para 4 of the said guidelines States have to adopt and issue necessary direction for its implementation. available, till date only 3 States viz. Kerala, Karnataka & Gujarat have As per the information adopted the said guidelines for implementation. But POWERGRID Board has already adopted said guidelines for implementation in November,
- Question No. iii) Dispersal of compensation under said guidelines has not yet started in any of the above States as the process for identification of land owners is under way in the State of Karnataka & Kerala for POWERGRID lines. Question No. iv)

- Question No. v) Since it pertains to action of MoP, it may reply suitably.
