SUB: INFORMATION UNDER RTI ACT 2005

Sir,

Please provide me following information under RTI Act 2005 with regard to Powergrid Corporation of India Limited under Ministry of Power:

1. Name and Employee Numbers of Employees of Powergrid (Retired or working) whose children/wives also got employment in Powergrid after January 2007. Names and Employee Numbers of those children/wives who got permanent service after January 2007 on the rolls of Powergrid also required.
2. What procedure is adopted in Powergrid where candidates are selected based on interview. Please also provide names and employee numbers of employees whose children/wives are appointed in Powergrid on interview basis after year 2007.
3. Names of the employees working in Power Ministry, whose children/wives got employment in Powergrid after 2007.
4. It has come to the notice of undersigned that Dr. Bharadwaj (Doctor appointed by Powergrid not on permanent basis) who is continuously with Powergrid for more than 20 years. What procedure is being followed for selecting the same Doctor for more than 20 years?
5. What type of qualification degree Mr. Shiv Kumar Verma, an accupressurnist is having, who is engaged by Powergrid for its employees? What remuneration is being paid to him on monthly basis?
6. An employee of Powergrid, Mr. Vinod, Employee No. 01333, who works in Library Department at Powergrid office. Gurugram recently deputed for 1.5 months at the

Which executive had given written/verbal order regarding this deputation? Will Shri S.K. Chaturvedi pay to POWERGRID for these services or the charges for this service will be borne by concerned executive who had given this order?
