Dear Sir,

I am Neha Sharma, ex employee of Power Grid Corporation of India, ID No. 03284, I worked in the organization from 31st August 2015 to 30th October 2015 for two months. I had earlier sent email to Mr. A K Gautam, DGM Finance and Ms. Simmi Arora, Manager Finance for sending me my form 16 for filing my Income Tax Return.

I received my form 16 at my home address. However, there has been a mistake in the generation of my form 16. At the time of my joining the power grid recruitment staff asked me to submit a dummy PAN No. As it was my first job I did not possess a PAN card at the time of joining. Then I gave the PAN No. of my father as a dummy PAN No. Later when I received my own PAN card and I informed about the details to the power grid personnel but it seems that it was not updated in my records. Therefore, the form 16 states that the entire amount of salary and deductions are showing in my father's name on his PAN card no. AGCPS9906M.

So in order to resolve this issue I have repeatedly sent emails dated 04.08.2016, 12.08.2016, 13.10.2016, 11.11.2016 for revising my form 16 in my name as I as well as my father are unable to file IT Returns. Since then Power Grid officials are not cooperating and I have received no reply in this regard. Also, I have made telephonic conversation with power grid personnel from the finance namely Ms. Simmi Arora, Manager Finance and Mr. A K Gautam, DGM Finance and legal department but no response has been received by me till date in this regard.
