Dear Sir,

This has reference to MOP's letter no. 11/4/2007-PG dated October 27, 2009 forwarding the comments of CEA on the subject and POWERGRID's letter dated April 05, 2010 informing re-discussion of the subject scheme in the Standing Committee of Southern Region. In this regard, it is to inform that the transmission system for the subject scheme was again discussed with the constituent of Southern Region in the 30<sup>th</sup> meeting of Standing Committee on power system planning in SR on April 13, 2010 (copy attached) and agreed with the following scope:

- a) Establishment of 765 KV Salem Pooling station (initially charged at 400 kV);
- b) Tuticorin Pooling station – Salem Pooling station 765 kV D/c line (initially charged at 400 kV);
- c) Salem Pooling station – Salem 400 kV D/c (quad) line;
- d) Salem Pooling station – Madhugiri Pooling station 765 kV S/c line (initially charged at 400 kV).

In view of the above, it is requested that prior approval of Government of India under Section 68 of Electricity Act 2003 to implement "Common Transmission System associated with Coastal Energen Private Ltd. and Ind-Barath Power (Madras) Limited LTOA Generation Projects in Tuticorin Area – Part B" may kindly be arranged at the earliest.
