Dear Madam,

This has reference to your Online RTI request dated 1<sup>st</sup> April, 2015 seeking information under RTI Act, 2005.

In this regard, it may please be informed that the information sought is related to DPC proceedings of 2001 of Shri P. K. Sharma which is kept in the sealed cover. It may please be noted that the DPC proceedings are confidential in nature and contain personal information. Since the appellatant is a third party, information cannot be disclosed to her as per Section 8(1)(j) of the RTI Act, as the document contains personal information. This is also in line with the Hon'ble High Court of Delhi judgment dated 8<sup>th</sup> July, 2014 in the THDC India Ltd. Versus R.K. Raturi case.

Since, the reply of subject RTI request was missed out inadvertently, the information sought couldn't be provided within 30 days of period. The delay was unintentional and inconvenience caused is regretted, please. However, similar information has already been provide by our letter dated 23<sup>rd</sup> April, 2015 in response to your RTI request dated 4<sup>th</sup> April, 2015.
