- 1. Regarding Transmission system strengthening in Southern Region for evacuation of power from SEPL, MEPL, Thermal Powertech and Other developers in Krishnapatanam area:**

Common system associated with ISGS project in Krishnapatanam area

- a. Date of Commercial Operation (COD) regarding Establishment of 765/400kV, 2x1500 MVA Pooling station at Nellore. *Common*
- b. COD of LILO of both circuits of SEPL/MEPL-Nellore 400 kV Quad D/c line at Nellore pooling station. *Common*
- c. Status of Nellore Pooling Station -Kurnool 765 D/c line. *CMG*

Associated Transmission System of Krishnapatanam UMPP (Part C1)

- a. COD regarding Establishment of new 765/400 substation at Kurnool with 2x 1500 MVA ICTs and 1x240 MVAR bus reactor *Common*
- b. Status of LILO of N' Sagar-Gooty 400 kV S/c line at Kurnool (new) substation. *CMG*
- c. Status of Kurnool (new)-Kurnool (APTRANSCO) 400 kV Quad D/c line. *CMG*
- d. Status of Associated 400 kV bays at Kurnool (APTRANSCO) substation. *CMG*

2. Regarding Transmission System Strengthening in Southern/Western/Northern Regions for IPP developers of Southern region and having target beneficiaries in Northern and/or western region:

Under Scheme I:

- a. Status of Establishment of new 765/400 kV substations at Raichur, Sholapur and GIS at Pune with 2 x 1500 MVA ICTs and 1 x 240 MVAR bus reactor each along with associated 765 kV line bays at Raichur, Sholapur and Pune. CMG

Under Scheme III:

- a. Status of Establishment of 765 kV station at Sonipat by LILO of Bhiwani-Meerut 765 kV line. CMG
- b. Status of Sonipat-Kurushetara 400 kV D/c (Quad) line. CMG
- c. Status of Sonipat (new)-Sonipat (under construction) 400 kV D/c (Quad) line. CMG
- d. Status of Bulandshahar-Hapur (UPPCL) 400 kV D/c Quad line. CMG
- e. Status of Associated 765 kV bays at Jabalpur Pooling station, Orai, Orai (UPPCL), Bulandshahar, Hapur (UPPCL), Sonipat (HVPNL) and Sonipat substations. CMG

3. Whether completion of Transmission System can have deemed completion status even if associated schemes are not completed, based on part completion of schemes?
4. Whether mere completion of Transmission Schemes/Transmission System on 'No Load' charging basis, would entitle Transmission Utility to recover transmission charges?
