Dear Sir,

The undersigned is a natural citizen of India and hereby seeks the following information under the Right to Information Act, 2005 for inter-state transmission line project:

1. In view of the Tariff Policy in the year 2011 and Tariff Policy 2016, please provide me the list of total transmission projects allotted on 'nomination' basis to transmission service providers including the Central Transmission Utilities and the State Transmission Utilities since the commencement of Tariff Policy 2011
2. With respect to the projects allotted on nomination basis for point 1 above, please provide me the reasons and documents relied on supporting such allotments qualifying for 'urgent situations' and/or the 'compressed time schedules' as contemplated under Tariff Policy 2011.
3. With respect to the projects allotted on nomination basis for point 1 above, since commencement of Tariff Policy 2016, please provide me the reasons and documents relied on for supporting such allotments qualifying for exceptions on the ground of technological upgradation, strategic importance or urgency as contemplated Tariff Policy 2016.
4. With respect to projects allotted on nomination basis under point 1 above, please also provide me with the cost of project, their completion date and current status of each such project as on current date. Are the relevant agencies to whom the projects have been allotted on-track to meet the "urgent" timelines?
5. Please provide me with the copies of the consolidated data, since the commencement of calendar year 2011 till date, in respect of projects allotted on nomination basis, which have achieved /could not achieve completion within the stipulated timelines and their measure of delay in number of days/months and steps taken by the ministry.

6. In view of the level playing field, as provided under the applicable tariff policies, how many such tariff based competitive bidding projects have been won by and allotted to private companies providing transmission service? Please provide me with the consolidated data of such private companies providing transmission services who have won the transmission projects on tariff based competitive bidding since 2011.

7. Please provide me with the consolidated data of project allotted to Central Transmission Utilities and the State Transmission Utilities on the basis of tariff based competitive bidding since 2011.

8. What are the steps taken by the Ministry of Power for ensuring allotment of transmission projects by way of tariff based competitive bidding and in accordance with the tariff policy?

I understand that an empowered committee ("ECT"), under the chairmanship of Joint Secretary (Transmission) has been constituted to decide the method of execution for various transmission projects approved by ECT. This committee decides whether projects will be bid-out on tariff based competitive bidding basis, or will be allocated on nomination basis. Who are the members of this committee? Have any of the members made any disclosures about the potential conflict of interest that they may have in discharging their functions as members of ECT? If yes, please provide us copies of the disclosures made by such members.

Is the Ministry aware if any members of ECT have conflict of interest, to the extent that they have interest in getting the project awarded to a particular agency despite the overall mandate or terms or reference of the ECT members? If yes, what instructions have been issued by the Ministry to avoid such conflict of interest? Please provide us copies of the same.


