Sir,

Please find enclosed a copy of complaint dated 28.09.2015 Shri Amit Kumar Sinha on the above mentioned subject.

2. Shri Amit Kumar Sinha has submitted that he joined as Sr. Engineer in Power Grid Corporation of India Limited (PGCIL) in 2009 under PH quota. After training he was posted at Project site at Jharsuguda, Odisha which is 434 Kms away from his home town Dhanbad, Jharkhand. The complainant vide letter dated 31.07.2014 applied for request transfer to Eastern Region-I or near his home town Dhanbad, Jharkhand. He got a reply fro the Group Head Quarter HR Department, Bhubaneswar that his establishment will consider his request transfer after completion of Jharsuguda Project. He again gave two requests vide letters dated 11.05.2015 and 13.06.2015 for his transfer to his home town. Recently the complainant got a transfer order 21.09.2015 posting him to another remote location at Rayagada (Raigada) Odisha which is 810 Km away from his home town. He has requested for his posting at his home town, Dhanbad, Jharkhand or around 100 Km from his home town or Eastern Region-I.

3. As per DOP&T's OM No.14017/41/90-Estt. (RR) dated 10.05.1990 and OM No. AB14017/16/2002.Es (RR) dated 13.03.2002 physically handicapped employees may be given posting as far as possible subject to administrative constraints, near their native place or near their region.

4. DoP&T vide OM No. 36035/3/2013-Estt. (Res) dated 31.03.2014 (Copy enclosed) had issued the guidelines for providing certain facilities in respect of persons with disabilities who are already employed in Government for efficient performance of their duties. As per guideline 'H' there is a provision of preference in transfer/ posting which is reproduced below:-

"As far as possible, the persons with disabilities may be exempted from the rotational transfer policy/transfer and be allowed to continue in the same job, where they would have achieved the desired ;erformance. Further, preference in place of posting at the time of transfer/promotion may be given to the persons with disability subject to the administrative constraints. The practice of considering choice of place of posting in

P.T.O

case of persons with disabilities may be continued. To the extent feasible, they may be retained in the same job, where their services could be optimally utilized."

5. Section 59 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, hereinafter referred to as the Act, mandates the Chief Commissioner for Persons with Disabilities on his own motion or on application of any aggrieved person or otherwise to look into the complaints inter-alia, with respect to matters relating to deprivation of rights of persons with disabilities and to take steps to safeguard the rights and facilities made available to them.

6. In the light of the above, it is advised to consider the request of Shri Amit Kumar Sinha In the light of above instructions and to submit the action taken in the matter to this Court within 30 days from the date of receipt of this communication. It may also be ensured that persons with disabilities should not be deprived of their legitimate rights.
