Dear Sir

This has reference to the CIC Order ref CIC/LS/C/2012/000952 dated 29.12.2016 (**Annexure-I**) under RTI Act, 2005 in regard to RTI request of Shri Baljit Singh S/o Shri Nachhattar Singh (**Annexure-II**).

The Hon'ble CIC has informed that the applicant Shri Baljit Singh has filed RTI request dated 7<sup>th</sup> April 2012, in which the applicant has requested for information under RTI Act 2005. The Hon'ble CIC has further indicated that as per the complaint of the applicant, no reply has been provided for his request.

As per the Order, CIC had directed the First Appellate Authority, NRTS-1, POWERGRID, Gurgaon to conduct an enquiry to ascertain whether any information was provided by the CPIO within the mandated period and if provided, whether it was complete, relevant and correct. The enquiry report has been requested to be submitted within 45 days of receipt of the order.

The Enquiry was conducted by the First Appellate Authority, NRTS-1, POWERGRID, New Delhi and submitted that RTI application of Shri Baljit Singh was addressed to the Chief Manager (Corporate Communication), New Delhi and not to CPIO, NRTS-1 and the applicant has mentioned wrong address in his application. As the Corporate Communication Department is in Corporate Centre Gurgaon, the application was forwarded to POWERGRID, Gurgaon. Therefore, CPIO NRTS-1 forwarded the above referred CIC order to CPIO,CC Gurgaon and CPIO, NRTS-II, Jammu vide their letter dated 30/31.01.2017 (**Annexure-III**) for necessary action and submission of desired Enquiry report to CIC.

While investigating the matter, Corporate Communication Deptt, POWERGRID Gurgaon and CPIO, NRTS-II were requested to inform whether the reply to the referred RTI request was provided and provide the available information on the subject case. CPIO, NRTS-II intimated that transmission line for which information

has been sought is being looked after by Parbati Koldam Transmission Company Limited (PKTCL) and not by POWERGRID.

Further enquiring into the matter, it has been intimated that an RTI application asking information for the same transmission line, as referred in the present request was filed by the applicant vide letter dated 07.02.2012 to CEA. CEA vide their letter dated 07.03.2012 forwarded the RTI request to POWERGRID & Punjab State Transmission Company limited (PSTCL) (**Annexure-IV**). POWERGRID vide letter dated 14.01.2014 informed CEA that the referred transmission line is not being implemented by POWERGRID and is being implemented by PKTCL (**Annexure-V**). Further, it is observed that PKTCL vide their letter dated 21.02.2014 (**Annexure-VI**) has already sent all the desired information to the applicant. It has also been observed from the document that the matter of providing information to the applicant was heard by the Hon'ble CIC on 24.4.2014. Further, as per CIC order no. CIC/LS/A/2012/001487/SS dated 8.5.2014 (**Annexure-VII**) in this case, it has been clearly established that the information sought was provided by PKTCL to the applicant.


Considering the above aspects, it is submitted to the Hon'ble CIC that earlier RTI request filed by Shri Baljit Singh for Ludhiana-Koldam 400kV Transmission Line was already replied by PKTCL on 21.2.2014. Further, like earlier, this RTI request also do not directly pertain to POWERGRID and is related with PKTCL. However, if the applicant desires to seek any information on the subject RTI, the same shall be directly addressed to the PKTCL.

In view of the above, there is no reason for fixing the responsibility in POWERGRID for non-compliance.

**ORDER**

The Complainant had filed RTI application dated 07.04.2012 asking for certain information.

Dissatisfied over non receipt of information the statutory time frame, the complainant approached the Commission.

The Commission in exercise of power under Section 18(2) of the RTI act, 2005 deems it appropriate to initiate an inquiry over alleged obstruction in flow of information.

Accordingly, the instant matter is being sent to the FAA, Power Grid Corporation Ltd. to conduct an enquiry into the matter, either by himself or through a nominee officer of senior rank. While conducting the enquiry, the nominated officer shall peruse the relevant documents and give all the concerned parties an opportunity to be heard. He should also examine, whether any information was provided by the PIO within the mandated period and if provided, whether it was complete, relevant and correct.

The enquiry officer shall send the enquiry report to the Commission within 45 days from the date of receipt of this communication listing the reasons for not furnishing the complete and/or the delay in furnishing the information by the CPIO thereby fixing responsibility

and identifying the officer(s) so responsible. It is clarified that the non compliance of the present directions shall be viewed seriously.

The Commission shall take further action upon receipt of the enquiry report, if found necessary. The complainant shall be at liberty to approach the Commission, if the grievance subsists.



**ORDER**
