Dear Sir,

This has reference to your RTI request dated 5<sup>th</sup> March, 2017 received on 16<sup>th</sup> March, 2017 seeking information under RTI Act, 2005, in regards to expenditure incurred on the office & residence and other facilities/services of CMD/MD from 2014 to 2017.

In this regard, it is informed that POWERGRID CMD's office is an integral part of Corporate Office, situated in Gurugram and is operational since 2003. The office building is Eight storey building with total usable area of Approx 15000 SqmMtr & approx. 800 Employees are working here. Time to time repair /renovation works are carried out for proper upkeep of the building. The expenditure incurred in the building repair & maintenance is accounted as a whole and no separate account is maintained for any individual officers cabin including CMD.

Further, CMD residence is a part of POWERGRID township situated at Sector-43 Gurgaon, comprising of nearly 117 nos multistory apartment flats/Bungalows. Facilities for upkeep of premises is maintained for all Employees residing in the colony. The expenditure incurred in the Township repair & maintenance is accounted as a whole and no separate account of expenses for any Employee flat is maintained seperately. Further, there is no additional expenditure on services of CMD.
