The Transmission system under the scope of PGCIL are as follows:

- 765kV Ranchi-Dharamjaygarh-Sipat Inter-regional transmission line

- Jabalpur-Bhopal 765 kV S/C line

2. The quantum in MW of Long Term Open Access and Medium Term Open Access applications pending before PGCIL for the above Transmission System.
3. After the request for relinquishment of 750 MW LTA by Essar Power M.P. Limited quantum granted for Long Term Open Access and Medium Term Open Access for power evacuation within Western Region through already existing / under construction/ commissioning transmission lines from the period December 2016 till May 2017
