

## Annexure-I

**Query 1:** According to supreme court order issued on 26<sup>th</sup> Oct 2016 regarding equal pay for equal grade and work, every employee in an organization are liable to get equal pay for equal work whether on Contact or on temporary basis. Does this guide line is followed by the organization or not. Are employees getting the same benefit or not being the employee in the organization. And if yes, what are the benefits that employees are entitled with, in comparison to permanent or regular employee.

**Reply :** The principle of equal pay for equal work is already being followed in POWERGRID. The referred Supreme Court verdict is in the matter of State of Punjab & others vs Jagjit Singh & others.

**Query 2:** In terms of accelerated Career Growth Scheme (ACGS) Circular no. 638/2017 date on 08.06.2017 vacancies can be filled by a permanent or regular employee as it is not mentioned clearly. Contract or FTB (Fixed Tenure Basis) employees can also fill the form as they are eligible for the same designation as compared to regular employees.

**Reply :** Accelerated Career Growth Scheme (ACGS) is meant for regular employee only. Contract or FTB (Fixed Tenure Basis) employee can not apply Under ACGS.
