
2. The CEA team's observations are given under:

- (ii) The EDC should study CEA guidelines to furnish the data in prescribed format. The CEA guideline is available in CEA website cea@nic.in.
- (iii) Center should regularly conduct awareness programme on various topics such as disaster management, prevention of accidents first aid and safety, etc. for the participants.

3. The Hotline Training Centre of Employee Development Centre (EDC) at 400kV Hyderabad Station, Ghatkesar at Hyderabad, of M/s. Power Grid Corporation of India Ltd., Telengana satisfies various basic requirements in terms of institutional facilities, organization & staffing, training methodology, including on-job training and instructional capabilities for recognition under the provisions of CEA (Measures relating to Safety and Electric Supply) Regulations 2010 and as per CEA Guidelines for recognition of training Institutes. The institute has scored 50 with grade 'C' in the appraisal.
