

Query	<p>I would like to know whether Power Grid Corporation of India Limited will implement the rule of equal pay for equal work.</p> <p>If yes, from which month they will implement because Supreme Court has verdicted the equal pay for equal work during the month of October 2016 and will the temporary or contract basis employees be eligible to get their equal pay from the month of October 2016.</p>
Reply	<p>The query seems to be vague and not pertaining to any particular claim against POWERGRID.</p> <p>The referred Supreme Court verdict was in the matter of State of Punjab &amp; others vs. Jagjit Singh &amp; others.</p> <p>As such, the second part of the query pertains to a future event and accordingly answer to this query does not qualify as "information" as per clause 2(f) of the RTI Act 2005.</p>
