Information regarding allocation of relinquished quantity / capacity by phase-I generation projects in Odisha HCPTC-1 corridor

1. Total relinquished capacity by Phase – 1 generation projects.

Reply: Total relinquished capacity: 3117 MW. The information is available at POWERGRID website (www.powergridindia.com >> CTU Open Access>>Joint Coordination Committee Meetings>>Eastern Region).

2. Dates of allocation when the relinquished capacity/quantity of phase 1 generation projects is allocated to the application/applicants in queue for LTA in HCPTC-1 corridor.
3. Dates as and when PGCIL has considered the relinquished capacity of phase 1 generation projects for calculation of ATC/TTC for allocations of capacity under LTA.

Reply (2 & 3): The HCPTC-1 corridor was planned for generation projects in Odisha (in vicinity of Angul and Jharsuguda) and comprise of high capacity transmission system traversing from Eastern Region (Angul) to Northern Region via Western Region for delivery of power to the Target Region(s). As such, after aforesaid mentioned relinquishment of LTAs there is no applicant located in Odisha (in vicinity of Angul and Jharsuguda) in queue seeking LTA in HCPTC-1 corridor. However, a part of the corridor between WR and NR was utilized to the extent of 559 MW in terms of the directions of Hon'ble CERC in order dated 28th October, 2016 in Petition No. 84/MP/2016 (the order is available at CERC website).
