Information Sought:

Question 1- We would like to have how many staff are there.....pls furnish name, DOB, designation, photo, address, mobile no in India and abroad..... Also tell us for how many years are they posted in particular office at that particular designation. Also provide retirement date....?

Reply: As on date total employee strength in POWERGRID is 8948. Further compilation of information of all 8948 employees, office wise with name, photo, address, mobile no, no of years at designation etc is voluminous, not readily available in the form requested and may disproportionately divert the resources of the organization in compilation so is avoided under Section 7(9) of RTI Act. If Information regarding any particular employee is required, the same can be provided. Also, few details requested like photo, address, mobile no are personal information, so is avoided under Section 8(j) of RTI Act.

Question 2- How many branch office are there and how many staff are employed in that branch office? pls furnish name, DOB, designation, photo, address, mobile no in India and abroad..... Also tell us for how many years are they posted in particular office at that particular designation. Also provide retirement date....?

Reply: As on date POWERGRID has a Corporate Office, 10 Regional Head Quarters, 220 sub-stations and various transmission line/consultancy/telecom offices etc across India. Further compilation of information of all 8948 employees, office wise with name, photo, address, mobile no, no of years at designation etc is voluminous, not readily available in the form requested and may disproportionately divert the resources of the organization in compilation so is avoided under Section 7(9) of RTI Act. If Information regarding any particular employee is required, the same can be provided. Also, few details requested like photo, address, mobile no are personal information, so is avoided under Section 8(j) of RTI Act.

Question 3 – As per finance ministry Act 1970 no one can work more than 3 years 1 day at same post. Pls furnish details of their posting at that particular designation.

Reply: Information sought is voluminous, not readily available in the form requested and may disproportionately divert the resources of the organization in compilation so is avoided under Section 7(9) of RTI Act. If Information regarding any particular employee is required, the same can be provided.

Question 5 –Pls provide mobile no of all employees as its payment is done by GoI.....


Reply: Details requested is personal information, so is avoided under Section 8(j) of RTI Act.
