

### **Query:**

Also provide me the question paper and answer key of all the exams for the recruitment of permanent faculty (assistant professor/lecturer) for the associated college or/and its constituent colleges or schools for Electronics and Communications branch/ Electrical Branch.

Also provide the above information for the organizations departments/units/centres which comes under your department.

Also provide me the complete notification with corrigendums or advertisements of all such exams mentioned above from the year 1990 to till date.

Also provide the weightage of written test, group discussion and interview for the above said recruitment.

### **Reply:**

The query seems to be vague and not particularly pertaining to POWERGRID or any of its particular recruitment process. However, in reply to the above queries the following points are stated:

- As per the practice followed in POWERGRID, all Question Papers are destroyed after completion of the selection process.
- Due to the nature of our business a majority of our induction is done in the discipline of Electrical Engineering only. In the past 20 years, there have been numerous recruitment processes for Electrical Engineering and Electronics Engineering at different induction levels through Written Tests. All relevant information viz. Employment News notifications, newspaper advertisements/corrigendums, website notifications as well as weightages given to different selection stages are present in respective subject files.

These records are voluminous and present in numerous files spread across different locations. Please specify the particular recruitment process/sub-process for which information is required.
