	Reply	The information sought pertains to personal information of third party, the disclosure of which has no relationship to any public activity or interest and which would cause unwarranted invasion of the privacy of the individual. Hence, the information cannot be provided under Clause 8 (1) (j) of RTI Act.														
2	Query	What is the process of engagement of the consultants, that is, if any publicity is given for selection/recruitment of consultants , process of selection etc.														
	Reply	In case of retired POWERGRID employees, shortlisting is done from among the retired POWERGRID employees meeting with the requisite criteria. In case of others, shortlisting is done as per requirement of the indenting department.														
3	Query	Who is the competent authority to approve the engagement of the consultants														
	Reply	Director (Personnel)/ Chairman & Managing Director based on recommendation of selection committee														
4	Query	What is the upper age limit for the consultants														
	Reply	The upper age limit of consultants should not exceed 65 years.														
5	Query	What is the policy followed by your organisation regarding their emoluments, fee as consultants, if there is any ceiling for such emoluments, if so, please furnish the copy of such rules.
