1. Regarding Transmission System strengthening in Southern Region for evacuation from SEPL, MEPL, Thermal Powertech and other developers in Krishnapatnam Area:

Common system associated with ISGS project in Krishnapatnam area

- (a) Date of Commercial Operation (COD) regarding Establishment of 765/400kV, 2x1500MVA Pooling Station at Nellore

Reply: Date of Commercial Operation (DOCO) of the elements is as follows:

765/400kV Pooling Station at Nellore – 01.04.2013

765/400kV, 1x1500MVA Transformer at Nellore Pooling Station – 01.02.2014

765/400kV, 1500MVA 2<sup>nd</sup> Transformer at Nellore Pooling Station – 01.03.2014

- (b) COD of LHO of both circuits of SEPL/MEPL – Nellore 400kV Quad D/C line at Nellore pooling Station

Reply: DOCO of the above element is 01.04.2013.

Associated Transmission System of Krishnapatnam UMPP (Part C1)

- (a) COD regarding Establishment of new 765/400kV sub-station at Kurnool with 2x1500MVA ICTs and 1x240MVAR bus reactor

Reply: DOCO of the above elements is 01.04.2014.

3. Whether completion of Transmission System can have deemed completion status even if associated schemes are not completed, based on part completion of schemes?
4. Whether mere completion of Transmission Schemes/ Transmission System on “No Load” charging basis, would entitle Transmission Utility to cover transmission charges?

Reply: for 3&4

The approval of Date of Commercial Operation of inter-State Transmission Systems and the applicable tariff is decided by Central Electricity Regulatory Commission (CERC) as per the provisions of prevalent Tariff regulations.



The Transmission scheme mentioned at point No. 2 (under Section-III) was agreed during the 28<sup>th</sup> Standing Committee Meeting on Transmission Planning for Northern region held on 23/02/2010 as an Associated Transmission system for various IPPs in Southern region with target beneficiaries in NR. Subsequently, during 31<sup>st</sup> Standing Committee Meeting on Transmission Planning for Northern region held on 02/01/2013, it was informed that this scheme was not taken up for implementation considering the slow progress of generation projects in Southern region.
