The information/documents are requested pertaining to the "HCPTC – II, Transmission System for Phase 1 Generation Projects in Jharkhand and West Bengal Part A1" in Eastern Region" ('Transmission System').

The Transmission system under the scope of PGCIL are as follows:

• **In Eastern Region**

- a. 400 kV Pooling Station (Jharkhand Pool) near Essar & Corporate Generation Projects.
- b. Ranchi – Jharkhand Pool – Gaya 400 kV D/C Line

• **In Northern Region**

- a. New 2x1500 MVA, 765/400 kV substation at Varanasi and Kanpur.
- b. Gaya – Varanasi 765 kV S/c.
- c. LILO of Tillaiya - Balia 765 kV S/C at Varanasi.
- d. Varanasi – Kanpur 765 kV D/c.
- e. Kanpur – Jhatikra 765 kV S/c.
- f. 400kV connectivity for new 765/400kV S/s at Varanasi & Kanpur

Following are the information sought from PGCIL for the above related transmission system -

1. Actual capability in MW, average load Flow in MW & peak load flow in MW and Utilization of the above transmission systems from July 2016 till May 2017 on month to month basis under Long Term/Medium Term/Short Term transactions or any other utilization for system strengthening. C101 P05000
2. The quantum in MW of Long Term Open Access and Medium Term Open Access applications pending before PGCIL for the above related Transmission System. C70
