Information sought from PGCIL for HCPTC-I transmission system under RTI Act, 2005 by Sh. Nitin Arora:

**Point no : 1**

Details such as actual capability, average/peak power flow and utilization of the transmission system on a month to month basis are not maintained by POWERGRID.

**Point no : 2**

After the relinquishment of 720MW LTOA by Navbharat Power Projects Ltd. no other application has been received in the vicinity of Odisha Phase-I Generation Projects for transfer of power under Long Term Access.
