

Query	<p>The Supreme court has held in one of its decisions that the principle of equal pay for equal work must be implemented. It was also held by the court that in case similar job is undertaken by regular and temporary or contract employees, there must not be any anomaly between the said categories in a welfare state.</p> <p>Does the department of Public Enterprises know that the employees working on temporary or contract basis for Power Grid Corporation of India are deprived of equal pay for equal work from POWERGRID Ltd. till now.</p> <p>If DPE knows about it then what action DPE is planning to take or has already taken.</p>
