

Information/Reply regarding Raigarh-Pugalur 800 KV HVDC Project:

1. What is the timeline of this project from start to commissioning.

**Reply:-**The project is accorded investment approval in May'16 with schedule completion of 42 months from the date of investment approval, i.e. completion by Nov'19.

2. What are the milestones in term of activity to be completed by which date.

Reply:-The following were major milestones of the project as per Investment approval

- i. Award of Major work Packages: Progressively by Jul'16
- ii. Acquistion of land for HVDC station: Mar'16
- iii. Engineering, Procurement, Manufacturing, Supply & Erection.: Jul'16 to Sep'19.
- iv. Commencement of site civil works.: Oct'16.
- v. Completion of equipment supply & erection: Sep'19
- vi. Testing & commissioning: May'19 to Nov'19
- 3. What milestones are completed.

Reply:- The following major milestones have been completed

- i. All major work packages have been awarded.
- ii. Land for HVDC station has been acquired.
- iii. Engineering, procurement & manufacturing as well as site works of various equipments & materials have commenced.
- 4. What measures are being taken to ensure that the main contractor for this project is following the timeline.
  - **Reply:-**The project activities are regularly monitored & reviewed against agreed schedules/commitments and necessary corrective actions are taken to ensure the timelines..
