

Query 4	Please provide complete merit list for ET(Electrical) with marks and category of the selected candidates in ET(EE) GATE 2017
Reply	Information regarding selected candidates can only be provided after completion of joining process.
Query 5	Does POWERGRID release 2 <sup>nd</sup> list if the vacancies are not filled? If yes, then what is the probable date of release of 2 <sup>nd</sup> list of ET(EE) through GATE 2017
Reply	In the event of non-joining/medical unfitness of any of the selected candidates, substitute offers of appointment may be issued to candidates from the wait list in the order of their respective merit positions within category. However, the query regarding probable date of issue of substitute offers pertains to a future event which is yet to happen and accordingly its answer does not qualify as "information" as per clause 2(f) of the RTI Act 2005.
