ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal dated 5th September, 2017 from Sh. Vivek Kumar stating that he has not received any information on his application dated August 2nd 2017. The appellant herein had sought following information and record;

Documents containing details of all leaves availed by Mrs. Supriya Singh, Senior Law Officer (Emp. No. 02928) from her joining POWERGRID in 2013 till date. The details should include dates, types of leaves: CL, EL, Medical etc., and reasons for the leaves.

On receipt of the Appeal, relevant papers were perused. It can be seen that based on the inputs received from the concerned department the appellant, was informed by CPIO vide letter dated 21st August, 2017, that the information regarding details of all the leaves availed till date by Mrs. Supriya Singh cannot be provided as the same is exempted from disclosure as per section 8(1) (j) of RTI Act, 2005.



Decision

I am of the view that the information sought by Appellant relates to personal information and its disclosure has no relationship with any public activity or interest and the same is exempted from disclosure as per section 8 (1) (j) of RTI Act, 2005. I agree with the decision of CPIO of not disclosing the personal information of an employee.

The Appeal is accordingly disposed of.
