

1. What is the present gross and in-hand salary per month in the grade E2A at Gurgaon with basic pay of INR 24900 in the first year of employment (training period)

Reply : The following components are paid in E2 grade during training period:

- Basic pay
- Dearness Allowance (119% of Basic Pay w.e.f. 01.07.2017)
- Perks – 17% of basic pay

2. What is the present gross and in-hand salary per month in the grade E2A at Gurgaon with basic pay of INR 24900 after first year of employment.

Reply: The following components are paid in E2A grade

- Basic pay
- Dearness Allowance (119% of Basic Pay w.e.f. 01.07.2017)
- Perks – 49% of basic pay
- Performance Related Pay – 40% of basic pay (max. ceiling)
- Accommodation (HRA/Lease/Company Quarter)

3. What is the expected gross and take home salary post implementation of third pay review committee for both the above points.

Reply: This is a question on future event which is yet to happen and accordingly answer to this query does not qualify as “information” as per clause 2(f) of the RTI Act 2005.
