Dear Madam,

With reference to your letter dated 12-07-2017 & 24-07-2017 regarding release of all terminal benefits payable against death of Late Bishu Halder, Emp. No: 41063, Security Guard, Malda,

- After the unfortunate death of Shri Bishu Halder, we have received claims for payment
- a) Ms. Priyanka Halder, D/o Late Narendra Kumar Saha, Mangalbari(Ghoshpara), Malda Vide letter dated 02-05-2012 addressed to CM, Malda.
- b) Shri Jatan Halder, Vide letter dated 27-04-2012 addressed to POWERGRID, Kolkata. AGM(HR),
- While examining our records, we have come across the following:
- a) A Petition (representation) dated 20-04-2006 from Ms Priyanka Halder addressed to CM, Malda for inserting her name in the Official records as Wife & pass necessary order/direction upon her husband to pay maintenance @ Rs.6000/- pm.
- b) A divorce petition dated 18-11-2011 filed by Bishu Halder against Ms Priyanka Halder in the Court of District Judge, Malda Vide Matri. Suit No. 443 of 2011.
- c) After the death of Bishu Halder on 24-04-2012, a letter dated 25-04-2012 we have received from Sh. Saibal Mitra, Advocate Malda informing that two cases—one for Divorce & another for Maintenance are pending before Learned Judicial Magistrate 2nd
- d) In light of above, both Ms. Priyanka Halder & Shri Jatan Halder were requested to obtain Succession Certificate from Competent District Judge Vide our letter No. ER-II/HR/IE/DRS/41063/1667 dated 31-05-2012.
- e) Vide your letter dated 22-06-2012, you had sought the details of amount towards DRS & Terminal Benefits payable by POWERGRID. We had intimated you the details of total dues which are payable consequent to death of Sh. Bishu Halder Vide our letter dated 10-07-2012.
