Query:

"This is with reference to the following tenders with following Specification Numbers :

CC-CS/741-CC/MISC-3348/3/G8 Package -A for Procurement of 420kV RIP Bushing.

&

CC-CS/741-CC/MISC-3349/3/G8 Package -B for Procurement of 245kV, 145kV and 52kV RIP Bushings.

In this tender the qualification requirement of bidder is as attached (Annexure-A BDS).

INFORMATION REQUIRED UNDER RTI ACT 2005 AS FOLLOWS :-

The techno-commercial documents submitted by all the bidders (Xian XD High Voltage Bushing Co. Ltd., Massa LLC also IZOLYATOR Company, ABB Switzerland, NANJING ELECTRIC GROUP CO. LTD.) participated in the said tenders against the attached qualification requirement i.e. documents submitted/uploaded against envelop-1 of bid."

Reply:

With reference to the information sought, it may please be noted that the bidding processes of the referred packages are yet to be completed, i.e., the awards of the contracts of these packages are yet to be published. Accordingly, the information relating to the evaluation of bids inter-alia the documents submitted / uploaded by the bidders as their 1st Envelope bids cannot be disclosed until the publication of the corresponding contract awards. Further, the information sought (i.e., techno commercial documents submitted by the bidders against the specified qualification requirements of these procurement packages) pertains to third parties and the same may be shared only after affirmation from the related third parties and that too only after completion of the Bidding processes and publication of contract awards.
