Reply to RTI Queries by Sh. Raghav Pandey

Query	The Supreme Court has held in one of its decisions that the principle of equal pay for equal work must be implemented. It was also held by the court that in case similar job is undertaken by regular and temporary or contract employees there must not be any anomaly between the said categories in a welfare state
Reply	This is applicant's own statement. No information has been sought.
Query	As in terms of DOPT OM No-49014/2/86 Estt© dated 07.06.1988, equal pay for equal work already exists for temporary or contract employees. On a RTI, DPE replied that implementation of equal pay for equal work rule for temporary or contract employees depends on the parent ministry
Reply	This is applicant's own statement. No information has been sought.
Query	As Ministry of Power is the parent ministry of Power Grid Corporation of India Ltd, does the Ministry of Power knows that the employees working on temporary or contract basis for the POWERGRID are deprived of equal pay for equal work from POWERGRID till now.
