Reply to RTI Queries by Sh. Raghav Pandey

Query	Vide reference No. CP/RTI/2017/156 POWERGRID replied to a request forwarded by Ministry of Power seeking information regarding equal pay for equal work for the employees working in the contractual or temporary basis. POWERGRID replied that the principle of equal pay for equal work is being followed in POWERGRID.
Reply	This is applicant's statement. No information has been sought.
Query	In POWERGRID many contractual employees are working for various projects. Engineers working in contractual basis has been designated as FE and supervisors as FS.
Reply	This is applicant's statement. No information has been sought.
Query	As per POWERGRID norms FE will be treated in the grade of E1 (lowest grade of executive) and FS will be treated in the grade of S1 (highest grade of supervisor)
Reply	This is applicant's own statement which is factually incorrect. No information has been sought.
Query	POWERGRID is paying consolidated pay to the FE and FS which is less than half of the salary of the employees working in same E1 and S1 grade in the permanent positions. Even employees working in the workmen (technician) categories are receiving more salary than the FE and FS. In spite of Supreme Court verdict of equal pay for equal work to the contractual or temporary workers, POWERGRID is exploiting the contractual or temporary employees serving as FE and FS.
Reply	This is applicant's own statement which is factually incorrect. No information has been sought.
Query	Does Ministry of Power taking any initiative to implement equal pay for equal work for the contractual or temporary employees serving as FE and FS for POWERGRID.
Reply	Applicant in past has asked for certain information regarding the above query. He has already been duly replied to. No new information is sought.
