

OFFICE MEMORANDUM

Subject:- Order under section 113(Power to Remove Difficulties) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 to extend benefits of compensation, rehabilitation and resettlement mentioned in First, Second and Third Schedules to the Acts mentioned in the Fourth Schedule of the Act.

The undersigned is directed to convey that the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Removal of Difficulties) Order, 2015 has been published on 28th August, 2015 and the same was uploaded on the website [www.dolr.nic.in](http://dolr.nic.in) on 29th August, 2015 ([http://dolr.nic.in/dolr/downloads/pdfs/RFCTLARR%20\(Removal%20of%20Difficulties\)%20Order,%202015.pdf](http://dolr.nic.in/dolr/downloads/pdfs/RFCTLARR%20(Removal%20of%20Difficulties)%20Order,%202015.pdf)). The said order envisages that the provisions of Right to Fair Compensation and Transparency determination of compensation in accordance with the First Schedule, rehabilitation and resettlement in accordance with the Second Schedule and infrastructure amenities in accordance with the Third Schedule shall apply to all cases of land acquisition under the enactment specified in the Fourth Schedule to the RFCTLARR Act, 2013.
