

- The Proposed Transmission system for evacuation of power from Lahaul & Spiti in Himachal Pradesh was deliberated in the 30th Standing Committee Meeting of Power System Planning in Northern Region held on 19/12/11. It was also decided that the implementation of corridor shall start after the submission of Construction Phase Bank Guarantee by the 1st applicant in the corridor.
- Till date no Construction Phase BG has been received. Further, no agreement has been signed by any applicant/generator so far.
- Further, as per the Task Force Report prepared by CEA/POWERGRID in consultation with officials from Himachal Pradesh, the list of hydro projects envisaged to be connected in Lahaul & Spiti area is tabulated below:
