ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal dated 6th November, 2017 from Sh. Joginder Singh. An application dated 29th September 2017 was filed by the Appellant herein with the CPIO, Corporate Centre, POWERGRID under RTI Act, 2005. Brief details of information sought are as below:

- (a) List of Employees, who are posted at CC, Gurgaon for more than 5
 years (barring dept. to dept. transfer) excluding Directors and
 Chairman.
 - (b) List of employees belonging to Delhi and NCR (Noida, Greater Noida, Ghaziabad, Gurgaon etc.).
 - (c) Number of employees availing self-lease in Delhi and NCR
- (a) List of Employees, who are posted at RHQ, Jammu for more than 5years. (barring dept. to dept. transfer) excluding GM and ED.
 - (b) List of employees belonging to Jammu.
 - (c) Number of employees availing self-lease in Jammu.
- Other queries/advice which are not mentioned herein for the sake of brevity.

On receipt of the Appeal, the details were sought from CPIO. CPIO informed that the Information has already been provided to the appellant vide letter dated 17th November 2017.

Decision

I am of the view that the information sought by the appellant herein has already been provided by the CPIO vide letter dated November 17th, 2017. It is apposite to mention that after perusing the records and RTI request of the appellant it appears that the appellant has not only sought certain specific information, but also views/ reasoning/opinion of the public authority in certain queries which is beyond the purview of the RTI Act, 2005. Information under section 2(f) of the Act only refers to such material as is available in records of the public authority. Public authority is not obliged to give advice/opinion as same is beyond the mandate of the Act.

The Appeal is accordingly disposed of.
