ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal No. PGCIL/A/2017/60091 dated 24th December, 2017 from Sh. Rahul Mishra. An application dated 5th Oct' 2017 was filed by the Appellant herein with the CPIO, Corporate Centre, POWERGRID under RTI Act, 2005 seeking information regarding Performance Related Pay (PRP) during his tenure in POWERGRID on Fixed Term Basis. As per appellant, he got PRP for FY 2008-09 but did not get any PRP for FY 2009-10, FY 2010-11, FY 2011-12, FY 2012-13 (Till Sep 2012). The appellant further requested CPIO to get his PRP released.

On receipt of the Appeal, the details were sought from CPIO. CPIO informed that financial year wise PRP along with details have already been provided to the appellant vide letter dated 10th Nov'2017.

The appellant further filed an RTI application claiming that the PRP paid was only partial deviating from his earlier statement that no PRP was paid to him for FY 2009-10, FY 2010-11, FY 2011-12, FY 2012-13 (Till Sep 2012). Appellant further asked for information regarding range of PRP percentage for E1 post in each financial year along with details of % PRP paid to him.

Decision

I am of the view that the information sought by the appellant herein has already been provided by the CPIO vide letter dated November 10th, 2017. Any information which was not part of original RTI application may be requested by filing fresh RTI application with CPIO.

The Appeal is accordingly disposed of.
