Information sought by Sh. Sachin, Najibabad, UP
under the RTI Act, 2005.

The information sought by the requester is general in nature and do not pertain specifically to any transmission line of POWERGRID. However, following may be noted:

CEA's Regulations for "Measures relating to Safety and Electric Supply, 2010" inter-alia stipulate under clause no. 61, that an overhead line shall not cross over an existing building as far as possible and no building shall be constructed under an existing overhead line. Further, under the subject clause, required minimum vertical and horizontal clearances of an overhead line conductor (under maximum sag & swing condition) passing above or adjacent to any building or part of a building are also stipulated. The minimum vertical and horizontal electrical clearances of overhead conductor under maximum sag & swing condition for 400KV line as per clause no. 61, works out to be 7.3m and 5.6m
