RTI by Shri Rituraj, 706, Empire Tower, Omex Heights, Sector-86, Faridabad regarding transfer of bond of employee

In view of DPE OMs dt. 13.06.1977 and 23.05.1981 i.e. regarding transfer of bond in the case of public sector employees joining services in Central Govt./State Govt./Autonomous Bodies/Other Govt PSUs, it has been noted that PGCII is not following this policy and thus not allowing transfer of service bond in case of employees leaving the corporation for joining services in Central Govt/State Govt./Autonomous Bodies/Other Govt PSUs and employees are required to pay bond money unfairly.

PGCIL behavior in this matter seems completely unfair as per laid down policy in Chapter-II of PERSONNEL POLICIES-Service Matters of DPE OMs No. BPE/GL01/77/MAN/2(11)/75-BPE(GM-1) Dated 13.06.1977.

Kindly grant information if separate or different policy is applicable to PGCIL as other PSUs under ministry of Power are strictly adhering to DPE memorandum, if not, kindly notice this unfair policy practice of PGCIL.

Reply: DPE OM Para (a) clearly states transfer of bond is permissible if the employee has applied through proper channel during of currency of the bond.

As per Service Rules of POWERGRID and terms & condition of appointment, if an employee is under any type of bond obligation, no application will be forwarded for outside employment during the bond period.
