(A government Enterpries PSU), who was posted in HVDC Repeater Station Jhinjhak (U.P) NR-3 (Formerly NR-1) Since 1999 vide office order No. 20/99 Dt. 19.06.1999 Which is controlling by Power Grid HVDC Dadri (U.P). My father was completed 14 years posted in same place, HVDC Repeater Station jhinjhak is 10 KM distance from the jhinjhak Railway Station, company was allotted quarter (government) in Bhauti, Chakrapur Kanpur (U.P). However, My father was went daily to attend shift duty by train. Dated 05.02.2014 my father was came Kanpur after completion of Night shift, Unfortunately, accident happened my father died in catch of the Goods train in Jhinjhak Railway Station.

Information Sought: Afterwards, father was only sole bread earner of our family. However, All the responsibilities in my shoulder because my mother is

housewife, have two sister they are study.

So, I have applied Job in Power grid on compassionate ground on 15.04.2014 but its refused. They had given reasons following is: We would like to mention that in Power Grid, there is provision for employment to one of the dependents of the deceased employee who dies as a result of accident while on duty. In the Instant case, Late Mohd Islam Sheikh died due to accident but the cause of death is run over by a goods train on a railway track. Obviously, the accident has happened at a place where the employee cannot be conclusively said to have happened while on duty and as such the case is not covered under the purview of the aforesaid provisions/policy.
