Query 1	<p>I want to know why 27.5% of reservation not given to OBC candidates during campus recruitment of NIT Srinagar on 8th and 9th of August 2017.</p> <p>You have recruited 10 students from NIT Srinagar. 27.5% of 10 students should be 3 students, but you have recruited only 2 OBC candidates.</p> <p>I want to know why POWERGRID has violated the reservation policy of India during Campus Recruitment of NIT Srinagar on 8th and 9th of August 2017.</p>
Reply	<p>The applicable % of reservation for OBC (NCL) category in case of other than by Open Competition is 25.84% only.</p> <p>Number of vacancy for any category is not determined by directly applying the percentage on the total vacancy as indicated by applicant.</p> <p>POWERGRID has not violated any guidelines/rules/reservation policy during campus recruitment of NIT Srinagar on 8th and 9th of August 2017.</p>
